REQUEST FOR PROPOSAL

A. The purpose of this Request for Proposal (RFP) is to obtain a vendor, outside of a contract for services, to provide the annual preventative radio maintenance for portable and mobile radios for fiscal year 2022/2023.

D. The Sonora Police Department has the right to accept or reject any and all proposals submitted.

SPECIFICATIONS:

The Sonora Police Department is seeking proposals to provide the annual preventative radio maintenance for portable and mobile radios and repeater sites, outside of a contract for services, during the fiscal year of 2022/2023. The department has thirty-four (34) portable radios, twenty-six (26) mobile radios, one (1) primary repeater, and one (1) backup repeater, all of which need to have the annual preventative maintenance conducted on them.

The cost for maintenance shall be broken down into the following categories:

- 1. The rate for annual portable radio maintenance per portable radio and total for all thirty-four (34) portable radios.
- Rate for annual radio maintenance per mobile radio and total for all twenty-six (26) mobile radios.
- 3. Rate of the service call, if any.
- 4. Rate for annual repeater site maintenance per site and total for (1) repeater.
- 5. Rate for annual repeater site maintenance per site and total for (1) backup repeater.

6. Any other related charges to the performance of annual preventative maintenance associated with portable and mobile radios.

The Sonora Police Department knows and understands that a vendor will be unable to project costs to repair any problems identified during the preventative maintenance check.
